





In the first phase mainly so-called private data visualizations will be available. These can only be consulted by the participating health care providers health care experientiations and funding gaugements. For







FAQ HAND HYGIENE: HD4DP2 WEB VS HD4DP2 LOCAL

What is the difference between HD4DP 2.0 local versus HD4DP web?

HD4DP 2.0 Local:

- Installation of the HD4DP2 platform on a local server that on the premise of the data provider.
- Data is entered and stored locally, and than sent to HD.
- Login via local configuration.

HD4DP 2.0 Web:

- Online version of the data entry form using a HD4DP2 platform installed in a secure cloud solution (G-Cloud).
- Data is directly sent to HD and not accessible for DP.
- Login via EID.
- "Emergency" solution



FAQ HAND HYGIENE: HD4DP2 WEB VS HD4DP2 LOCAL

Can organizations, that are currently using HD4DP2.0 Web, later have local access to the data entered in the Web application after they moved to using HD4DP2.0 local?



Since the data is not patient sensitive, on request of the DP, a one-time manual data transfer can be facilitated from HD-DWH towards the local DB of the DP.

Important note: only the data that is entered in HD4DP2.0 Web can be transferred, not the historical data previously entered in the NSIH-Web application.

The historical data entered in the NSIH-Web application is used in the reports on Healthstat.be.
